AUTHORIZATION AGREEMENT FOR AUTOMATIC DRAFT FROM CREDIT CARD (EFT)

## MEMBERSHIP AGREEMENT TERMS & CONDITIONS

It is agreed by and between Art of Balance Wellness Spa, and you, the undersigned Member (individually, if you are the Member, and/or as agent or guardian of the Member or responsible party), that you are purchasing a Spa Membership from Art of Balance Wellness Spa (hereinafter "Spa") according to the terms of this Spa Membership Agreement and the current Terms & Conditions.

### YOUR CC BILLING DATE:

The Spa Membership fee will be automatically debited from Member's credit card each month, where the day of the debit will be determined by the day in which you have signed up for the Spa Membership or at the beginning of the month. This debit will continue on the same day each month thereafter until your Spa Membership is terminated in the manner provided below.

Member understands that Member is in full control of Member's payment and that this EFT/CC Request will remain in effect until the Spa receives written notice of termination of this Spa Membership Agreement and has a reasonable opportunity to act on that notice. If you decide to change your billing and credit card information, a 30-day notice is required.

### CANCELLATION POLICY:

I understand that subject to the cancellation rights described below, my membership will automatically continue each month until I cancel it by (1) GIVING 30 DAYS WRITTEN NOTICE PLUS (2) PAYMENT OF CANCELLATION FEE OF 25% OF THE REMAINING BALANCE ON THE MEMBERSHIP.

This Agreement shall become binding when signed by myself and accepted by Art of Balance Wellness Spa.

**ADDITIONAL RIGHTS TO CANCELLATION:** You may also cancel this contract without cancellation fee by providing reasonable proof of any of the following reasons:

- If upon a doctor's order, you cannot physically receive the services because of significant physical disability for a period in excess of six months. Doctor's letter required.
- If you die, your estate shall be relieved of any further obligation for payment under this contract not then due and owing.
- If you move your residence out of State.
- If the services cease to be offered as stated in the contract.

### APPOINTMENT CANCELLATION POLICY:

Appointments rescheduled with greater than 24-hour notice will not be charged a cancellation fee. If you are calling to reschedule with less than 24-hour notice, we will charge your card for 100% of the service(s) reserved. If you do not show up for an appointment we will charge your credit card in the amount of 100% of the service(s) reserved. It is up to the member to reschedule any cancelled appointments. This cancellation policy does not apply to member services that are moved due to spa business demand.



By signing this Spa Membership Agreement, Member acknowledges that Member is of legal age; has received a filled in and completed copy of this Spa Membership Agreement that identifies the Spa Membership type and services purchased; has read and understands the entire Spa Membership Agreement that includes but not limited to the \*EFT/CC Billing Date (if applicable) and the Cancellation Policy.

This Spa Membership Agreement constitutes the entire agreement of the parties and no other agreement or understanding exists between Member and the Spa. The Spa has not expressed or implied any warranty or representation other than those set forth in this Spa Membership Agreement to induce Member to enter into this Spa Membership Agreement.
